



## Notice of Township of Oro-Medonte Public Meeting for Amendments to Fees under the Ontario Building Code Act

March 31, 2025

Please be notified that a Public Meeting will be held on April 23, 2025 at 3:00 p.m, in the Council Chambers at the Township of Oro-Medonte Administration Centre located 148 Line 7 South, Oro Medonte, Ontario.

In addition to the Municipal Officer Report DS2025-034 presented to Council on March 12, 2025, the Council of the Corporation of the Township of Oro-Medonte will consider amendments to By-law 2024-134 respecting fees for Building Permit and Miscellaneous fees. Moreover, whereas Ontario Regulation 163/24 requires the Township to hold at least one public meeting to inform the public of the introduction or change in a permit fee under Section 7(1) of the Building Code Act.

The public meeting will include a presentation by Watson & Associates Economists Ltd., on the report findings related to the building permit fee amendments. Upon conclusion of the presentation any person in attendance will have an opportunity to make representations with respect to the matter related to proposed Ontario Building Code fee revisions.

The Township will make available information setting out an estimate of the costs of providing the services, the amount of the fees, and the rationale for imposing the fees, prior to the public meeting on March 31, 2025.

Input on the draft fees and charges by-law for the Building Division is welcome and encouraged.
