

# CONSTRUCTION NOTICE:

## CONTRACT: OCS-RFT25-005

LAKESHORE ROAD WEST DRAINAGE IMPROVEMENTS LINE 6 – LINE 7 – PART D



September 15, 2025

Starting the week of September 15, 2025 The Township of Oro-Medonte will begin construction work on Lakeshore Road West Drainage outlet improvements between Line 6 and Line 7 as shown on the map below. It is anticipated that only locate work will be completed over the first two weeks and full construction activity is expected to start the week of September 29th. Construction is projected to be completed by the end of October pending weather conditions and unanticipated circumstances.

### PLANNED CONSTRUCTION WORK

The scope of work under this Contract includes storm sewer installation, ditch improvements and minor road resurfacing in impacted areas.

Before the construction begins, underground utilities will be marked to avoid potential issues when digging.

### CONSTRUCTION IMPACT ON LOCAL RESIDENTS AND TRAFFIC

- Roads will remain open and lane restrictions will be put in place to allow construction activities to proceed in a safe and efficient manner. On certain occasions, daily road closures may be required for storm sewer installation. Residents will be given 3 days' notice prior to road closures and roads will be open during school bus hours and evenings
- Access to private driveways may be impacted at times during road reconstruction and associated work.
- Waste collection schedules will not change during construction, although the typical pickup time may be earlier than normal. Waste materials should be placed on the curbside by 7 a.m. on your designated collection day.
- Special arrangements for mail delivery and school buses will be made if required.
- Property owners/residents are reminded that underground systems such as lawn sprinklers, heated driveways and electrical conduits etc. may be within the Township-owned boulevard or property limits and may be impacted by the proposed construction work. The Township will not be responsible for damage to any privately owned items that are within the Township-owned boulevard or property limits including landscaping items

The Township appreciates your co-operation and patience as we work to complete the construction as quickly and efficiently as possible.
